Relevant Documents



- **Consolidated Plan**

- The 2010-2015 Consolidated Five-year plan is the state's plan that establishes goals and objectives for housing, community, public facilities, and economic development activities.
- Each year of the Consolidated Plan is updated to include the use of funds

- **Annual Action Plan**

- The Consolidated Plan is updated annually to identify and specify the use and amount of funds to meet the goals and objectives established in the Consolidated Plan
- Amendments which modify the original plan

Action Plan Amendment



- **Action Plan Amendment**
 - 2013-2014 Annual Action Plan Amendment open for public comment
 - ✦ Comment period began June 10, 2016 and ends on July 11, 2016
 - ✦ Available online
- **Amends Section V – Method of Distribution**
 - Amended language: “includes financial assistance for optional relocation where tenants have been or will be relocated within six (6) months of the relocation due to unsafe and potentially hazardous living conditions.”
