  - Tribal Tourism Program proposed activities for FY2027 requiring executive action (vote):
    - Continuation of event sponsorship agreements offered to eight tribal nations for summer 2027: vote
    - Tribal Tourism Grant: Vote on changes to guidelines; increase in maximum award amount and match requirement adjustment from 50% to 20%.
    - Tribal Tourism Small Business Grant: Vote on changes to guidelines; raise maximum award amount back-to-back awards, applicability of matching funds, should eligibility be expanded to descendency and what is considered eligible official tribal enrollment or descendency documentation.
    - Conference sponsorships: Vote on sponsored attendance and who qualifies, how they are selected and what should be covered with the use of Tribal Tourism Program funds (when funding is available and approved by Commerce).
