Corrected 2022 and 2023 Annual Report. (*) Correcting Advanced Deposit Wagering Deposits for 2023

In 2022 and 2023 horse racing continued a steady growth from its return in 2012 and untimely interruption from Covid. The \$628,000.00+ debt that was created in a three-year time frame 2009 to 2011 was retired. In 1965 the Board was started as a regulatory Board; it has evolved into a combination regulatory Board and an economic development Board. The Board is part of the Department of Commerce and would like to thank everyone there, the help and support that is provided is very helpful and much appreciated. Montana no longer receives funds from simulcasting. Simulcasting has been replaced with Advanced Deposit Wagering.

In 2012 Miles City Bucking Horse Sale returned racing to their very popular event, to date it is still going strong with a steady growth. This was followed by the Great Falls Turf Club State Fair Race meet. Which also continues to provide a successful race meet. These race meets provide dollars of support to not only the individuals involved in racing but millions of dollars of support to their respective communities. Montana has a long history of horse racing, going back to the late 1800's and early 1900's even having a horse born and trained in Montana going on to win the Kentucky Derby in the 1980's and 1990's Montana enjoyed a very robust industry with many communities providing race meets in conjunction with their fairs. Over 100 days of racing and over \$10,000,000.00 in handle generated.

Montana Owners and Breeders Bonus Program

By Statute and rule, Owners and Breeders of Montana foaled horses will share in the Montana Owners and Breeders program. 10% of the winner's share of the purse won by a horse bred in Montana shall be paid to the Breeder of the horse and an equal amount shall be paid to the Owner of the horse. These funds must be paid to the Board of Horse Racing to administer, then paid to the respective parties. In addition to these funds a portion of the source market fee generated through Advanced Deposit Wagering is set aside per statute then paid to the same Owners and Breeders of Montana Bred horses. The money generated is calculated according to the percentage of winning purse money for each horse.

Advanced Deposit Wagering

Statute 23-4-301 (7) States – The Board may license an advance deposit wagering hub operator to conduct advance deposit wagering. Advance deposit wagering is prohibited and illegal unless it is conducted through an advance deposit wagering hub operator licensed by the Board.

"Source Market Fees" paid to the Board are utilized to support the live horse racing industry. The funds are used to enhance purses, capital improvements and Owners and Breeders Bonuses.

In 2022 The Board allocated \$315,000.00 to the tracks for operations including purses, with another \$50,000.00 for equipment and capital improvements. In 2023 The Board allocated 360,000.00 for operations including purses and \$60,000.00 for capital improvements.

The Board no longer licenses Fantasy Sports and there is no longer a simulcast operator licensed in Montana. The Board debt was retired in 2019 retired.

Quick Review of 2022 and 2023 Horse Racing in Montana

Live racing at both Great Falls and Miles City has improved. Purses have more than doubled in two years. Both facilities are working to improve their facilities and equipment. We are seeing more individuals coming to Montana to race. The communities do a wonderful job of supporting live racing. Management works closely with the Board to continue to improve. The debt load for the Board has been retired.

Looking Forward to 2024

The Board has allocated \$480,000 of Advanced Deposit Wagering funds to the live race meets for operations including purses. The 2023 legislature passed legislation giving the Board \$250,000.00 annually to utilize for the racing industry. The Board, has initiated a Montana Bred incentive program, using a portion of the legislative funds. Thie incentive program will award money to all Montana Bred horses that are official starters at either Miles City or Great Falls, no matter where they place in a race. These funds will be in addition to the existing Owners and Breeders program. A portion of the legislative funds are also earmarked for capital improvements. Miles City is improving their horse stalls and Great Falls is purchasing track equipment. The remaining legislative funds are allocated for purse structure. The bottom purses at both facilities excluding futurity trials are projected to be \$6,000.00 up from \$2,500.00 three years ago. Both facilities will have 6 days of racing.

Miles City and Great Falls have entered into an agreement with 307 Racing in Gillette Wyoming to start the Golden Triangle Race Series. The Golden Triangle series allows for bonuses to be won for older Quarter Horses and Thoroughbred Horses along with a 2-year-old Quarter Horse if it wins the Quarter Horse Futurity at all three facilities.
